Overdose Prevention Program Community Mobilization Projects for Harm Reduction Services

- Vital Strategies is funded by Bloomberg Philanthropies to offer comprehensive technical assistance and support for <u>reducing</u> <u>overdose deaths in targeted states with high rates of</u> <u>overdose deaths</u>
- In November 2018, Governor Wolf and Mayor Bloomberg announced Pennsylvania as a state targeted for \$10M over three years
- Partnering with the University of Pittsburgh, School of Pharmacy – Program Evaluation and Research Unit (PERU) to support coalitions in advancing harm reduction strategies



RFP - Community Mobilization Projects for Harm Reduction Services

- \$50,000 is available per coalition
- One-time funding—non-renewable
- 12-month project period: July 2020 June 2021
- Allowable for <u>one or more</u> harm reduction strategies
- Up to 15 coalitions will be funded
- Pitt-PERU is assisting with delivering guidance on proposal development and administration of the subgrants – <u>use them!</u>

Program Framework

- Harm Reduction: Pragmatic public health approaches to
 - Minimize risk
 - Take precautions
 - Reduce negative consequences
- Health Equity: everyone has a fair opportunity to be healthy as possible, and promotes practices that aim to eliminate disparities in health and its determinants that affect marginalized groups
- Racial equity: eliminating racial disparities by applying strategies targeted to close the gaps in services access, delivery, and quality (Toolkit:

Naloxone distribution to people who use drugs and their networks



Syringe Service Programs

2. First responder partnerships



Law enforcement prearrest/pre-booking diversion to supportive services



Emergency medical service (EMS) leavebehind naloxone



Project Parameters & Activities

- Project Implementation: Direct funding to scale-up or support existing programs and services
 - New program or service
 - Meaningful <u>expansion</u> of current program or service
 - Planning <u>and</u> service delivery activities & deliverables
- Planning and capacity-building: Planning and coalition-building efforts to lay the groundwork for service implementation
 - Training, site visits, and community/stakeholder education
 - Policy, protocol and infrastructure development
 - Coalition-building, advocacy and community engagement











Syringe Service Programs



Project implementation

- Partnerships and support of HR providers in operations
- Fixed site (including healthcare provider)
- Mobile services
- Street outreach

Planning and capacity-building

- Conduct community & stakeholder education
- Develop service plan including needs assessment and approach to fill those needs, policies and procedures, staffing needs, outreach and recruitment methods, monitoring mechanisms, fundraising strategy, and budget
- Development and education on <u>model</u> local ordinances.

Budget Parameters

- Must be directly related to project activities (not supporting indirect cost or providing general operating support)
 - Staff support
 - <u>Direct assistance</u> to individuals (e.g. stipends, fees and incentives)
 - Hiring of a <u>consultant</u> to develop or review policies and protocols for improvements to better serve people who use drugs, and
 - Event space and other costs (e.g. trainings, community engagement, etc.)
 - Equipment & supplies (including naloxone & syringes)*
 - Marketing and promotion for community engagement and patient education
 - Other operations support <u>directly related to project</u> (e.g. travel, office supplies, technology, printing/copying, etc.)



Budget Parameters

- Must be directly related to project activities (not supporting indirect cost or providing general operating support)
- How strongly are the proposed expenditures <u>appropriate</u>, <u>feasible</u>, and focused on
 - (1) capacity building activities that will likely result in implementation (for planning projects), or
 - (2) <u>service delivery</u> to the priority population (for implementation projects)?

Quality and clarity of the proposal	Agency capacity : What is the level of the applicant's capacity, buy-in from essential partners, and relationships with the population to be served, to perform the proposed activities?	10
	Scope of work: To what degree are the proposed activities grounded in evidence, reflecting best practices, and aligned with priority harm reduction strategies?	15
	Workplan and timeline : To what degree does the workplan have clear deliverables and appropriate timelines?	10
	Evaluation plan: How clear is the data collection plan to evaluate project objectives?	5
	Budget: How strongly are the proposed expenditures appropriate, feasible, and focused on (1) capacity building activities that will likely result in implementation (for planning projects), or (2) service delivery to the priority population (for implementation projects)?	5
Reach and impact	Focus and reach: To what degree is the proposed project likely to reach people who are highest risk in the community, and does it serve to reduce health disparities?	10
	Jurisdictional level of need: To what degree does the relevant jurisdiction show indicators of need, e.g. fatal and nonfatal overdose rates and other key health indicators?	5
Sustainability and continuity	Sustainability: How clear is the sustainability and continuity plan?	10
